A member of the public raised concern about a proposed power cut on 19 July when UK Power Networks would upgrade power lines and poles on Scarborough. She was greatly concerned that not everyone in the village had been notified although she understood that the power cut would affect the entire village. A further concern was the impact on businesses which would be without electricity between 9 am and 12 noon.

E Meath Baker reported that the manager of the Farms Shop had communicated this concern to UKPN and it was believed that a special team would be used to carry out a 'live fix' in order to avoid cutting the power.

The Clerk was asked to clarify the situation with UKPN (Clair Rees said that she would scan the notice with the contact details and send it to the Clerk and the County Councillor).

Concern was also raised about the emergency road closure of the High Street by Anglian Water. The signs were at Barsham stating that the road was closed from 4 July. Although the signage included a notice stating 'businesses open as usual' it was not clear where the closure was and as a result people did not drive to Walsingham.

Another member of the public asked for an ATM machine in the village and suggested that the Anglicans and Catholics could organise this to allow pilgrims, visitors and residents get cash to support local businesses. The Chairman indicated that this request would be taken to the WDG.

Problems with the Mobile Post Office were raised again. A laminated A4 notice had been put up on the telegraph pole near the stopping place on Guild Street stating the there would be no post office on 27 June because the van was being serviced. However it had not appeared the following week either. K Richardson reported that the PO van would be off the road until 18 July. (Clair Rees said that she would scan the notice and forward to NCCIIr M Strong who wished to follow this up).

A request was made by a member of the public to have a slide for younger children on the Recreation Ground as the existing one was only accessible by a rope ladder.

An article would be in News and Views (due out beginning of August) informing the public of the police support and the numbers to call if problems arose – 101 (non-emergency), 999 (emergency).



- c) K Richardson pointed out that travellers were coming every weekend and some of them caused problems (e.g. some of the kids shop-lifting). She advised local businesses that they could also call Mgr John Armitage at the Catholic Shrine to assist with problems with travellers.

a) It was noted that the Royal British Legion have asked for permission to carry out a street collection for the poppy appeal between 28 October and 11 November 2017. The Parish Council had no objection.
