During the financial year ended 31 March 2024, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2023/24 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. Employers Role

The Council to note that advice given within Governance & Accountability 2024 Item 5.4

“Authorities with any employees are, by definition, employers and are required to apply Pay as You Earn (PAYE). PAYE taxes and employee and employer National Insurance contributions (NIC) should be calculated and recorded for every employee. Deductions should be paid to HMRC on or before the date prescribed.”

It is noted that the Clerk pays her own PAYE. Salaries and deductions should be calculated through HMRC RTI and evidence recorded. Employees are entitled to receive payslips. This can be an onerous task for a small council but the task can be outsourced at a competitive price (contact NPTS for service providers).

The above explains why I have been unable to tick the “YES” Box for Item G on the IA Report Page 3.
